PLEASE make every effort to attend at least part of the Conference this year in support of IFFR member President Len Smith and your hard working Committee.

# "KISS ME KATE!" or "We opened in Venice...."

The words of the lyric from this famous Musical well illustrate the appealing nature of the Italian Section Annual Assembly to be held on June 15-17 and to be followed by an optional Mini Tour for the next four days. Those who attended the 1989 Meeting at Varese will recall the superb venue and lavish hospitality of our hosts - this year promises even more!

The event will start at Perugia, midway between Florence & Rome, and served by an IFR equipped airport with Customs and duty-free fuel. After a buffet lunch a multilingual tour of the City will be followed by a municipal reception and Gala Dinner at the Relais San Clemente, a luxurious Hotel & Restaurant created from a Medieval Villa and converted to 4 star standards. This will be our base for the weekend.

On Sunday morning a guided tour of Assisi will precede lunch and then our departure for Elba. There sun swimming and sightseeing will occupy the Monday until the evening reception and dinner hosted by Elba Rotary Club. On Tuesday afternoon another short sea crossing will take us to Calvi in Corsica, where on Wednesday morning there will be a Boat Trip to the National Park of Girolata, before another Gala Dinner that evening. On Thursday the party will disperse, calling at Cannes for a final meal for those whose constitution (and considerations of weight & balance) will permit. Of course, those who under business pressures can resist the siren song of the next port-of-call may break off at their chosen point, so long as Carlo Vanoni the co-ordinator has amply warning of your intentions.

# THE DUSSELDORF DO

# HOW SO FEW ENJOYED A FABULOUS IFFR FLY-IN contributed by Graeme le Quesne

Perhaps it was the weather at the last minute, perhaps it was the distance, perhaps it was the change of date, but it was certainly a pity that so many IFFR members missed the opportunity to share in an International Fly-in which more than lived up to the traditions of fun and fellowship established over the years by older Sections than our German friends.

Centered in the Arabella Airport Hotel, which was a surprisingly calm and peaceful casis in the airport complex at Dusseldorf, Winfried Aufterbeck and his family had laid on a programme that left nothing out. Airborne arrivals were encouraged at nearby Monchengladbach on Friday, (although some had chosen to arrive earlier and make a holiday before the fly-in), and surface transport took guests to the hotel to prepare for a reception at Deutsch Bank. A chance to meet the other participants and to enjoy a gourmet meal in the Bank's own elegant dining room.

Saturday started on the coach at 09.15 to visit the new shopping mall KO-GALERIE where a talk of introduction and explanation of the thought and principles behind its creation was given by the architect and developer Walter Brune, before a guided tour of the more interesting aspects of its activity, from basement supermarket to roof top swimming pool, solarium, and health & fitness centre complete with rubberised surface jogging track.

An excellent lunch was waiting at the Airport, courtesy of HAPAG-LLOYD, and its Chairman IFFR Dieter Ulken, preceded by a most interesting presentation of the Company's growth as freight handlers and airline operators by the Dusseldorf Station Manager. Under the guidance of the Director of Rhine-Ruhr-Airport Dusseldorf, IFFR Bernd Rietdorf we were then treated to a full tour of the Airport itself - from its emergence as an International Airport to the plans for development, and a view of its operation including a demonstration by the Fire Service.

There was time for a well deserved rest and relaxation before the Gala Dinner at the official residence of the State President (a Rotarian of course) where we were joined briefly and most warmly welcomed by the District Governor. A superb dinner was served during the evening interspersed with the thanks and official greetings from the representatives of Switzerland, Italy, U.K. and Jersey, and messages of apology and good wishes received from those unable to attend including Jean Recullet. (The French section - Belgian branch helicopter division - had made attendance on Friday but other prior committments had required an early departure). The evening was rounded off with an American Auction (if you don't know what that is I'll tell you some other time) in aid of Rotary Foundation, and proved to be a hilarious way of raising over 1200 DM for a collection of worldwide Rotary stamps and Philatelic covers. We got to bed just before 02.00, or it may have been later but who was counting?

Not many were therefore available for the 09.30 departure for a city tour, to take in the signal tower and the Verige brewery, before a vin d'honneur and smack lunch reception by Lufthansa. It was then nearly 48 hours into the fly-in

and past experience has shown that there are limits to the constitution of even the staunchest IFFR member. Such was the case in Dusseldorf, and our thanks and congratulations go the Aufterbeck family team and their Rotarian colleagues for having "done us proud".

#### COMPULSORY THIRD PARTY INSURANCE FOR AVIATION

The Civil Aviation Authority, apparently as a result of Parliamentary pressure, has been asked to report of the feasibility of Compulsory Third party Insurance for Aviation. The Lawyers Flying Association wishes to present evidence to show that the risk of uninsured loss is too small in practice to justify the cost of imposing and policing such a scheme, but is hampered by lack of information about the extent of existing insurance and of any third party claims which have not been covered by insurance. To support them you are asked to complete and return the following questions in respect of any aircraft you own, operate or fly. Please give separate details for each plane you use, including gliders, balloons etc. Please return the completed form direct to Tim Scorer, Barlow Lyde & Gilbert, 7th Floor Beaufort House, 15 Botolph St. London EC3A 7NJ as soon as possible.

## BRIEF YOUR PASSENGERS BEFORE FLYING !

The Civil Aviation Safety Group have realised that whereas Airlines give a standard briefing on emergency procedures to all passengers as a matter of course, this is often overlooked by pilots of General Aviation aircraft, notwithstanding the legal obligation to do so. The CAA has produced what we consider to be the best of their Safety Leaflets, equally valuable to pilot and passenger in considering the aspects to be explained. They have been good enough to provide a copy for each IFFR member and your copy is sent with this Bulletin. Read it and then put it in your flight bag or plane and remember to tell every passenger of his expectations and responsibilities BEFORE you fly. It is too late when the fan stops, or he feels sick. A typed briefing sheet covering most singles is available on request to me.
